Pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, we would like to inform you that OMCs [Indian Oil Corporation Limited (IOCL), Hindustan Petroleum Corporation Limited (HPCL), Bharat Petroleum Corporation Limited (BPCL)] has opened a tender vide EOI no OMC/EOI/NUCO/BD/MAR25 (CYCLE1) Tender ID - 2025\_MKTHO\_184206\_1 dated 13<sup>th</sup> March, 2025 for supply of Biodiesel for total quantity bidding of 2,00,000 KL for the period of April 2025 to July 2025.

Pursuant to bids for the above-mentioned tender, Rajputana Biodiesel Limited and its Subsidiary Company i.e. Nirvaanraj Energy Private Limited have received Letters of Intent dated April 16, 2025 for supply of Biodiesel for aggregate 3,543 KL, having estimated order value of Rs. 30 Crores (approx.), during the period of April 2025 to July 2025.
