Strategic Updates on New Biodiesel Tender, Project Expansion, and Regulatory Approvals

We are pleased to share some significant developments at Rajputana Biodiesel Limited, along with its subsidiary Nirvaanraj Energy Private Limited, which mark important milestones in our growth journey and reaffirm our commitment to sustainable energy.

Our consistent success in securing contracts from India's leading Oil Marketing Companies reflects the superior quality of our biodiesel products and the reliability of our operations.

Key Highlight of Strategic Updates

- In line with our vision for capacity expansion and environmental compliance, we have also received approval for Consent to Establish and Consent to Operate under the Water (Prevention & Control of Pollution) Act, 1974, and the Air (Prevention & Control of Pollution) Act, 1981. This approval allows us to manufacture biodiesel at capacity upto 90 KL per day at our manufacturing facility located in Phulera, Rajasthan.
- We are proud to inform you that we have been successfully in securing of a prestigious allocation for the supply of 5,405 KL of biodiesel to IOCL, BPCL, and HPCL. This tender, valued at approximately ₹43.50 crore, spans the period from September 2025 to October 2025. This achievement not only strengthens our revenue visibility for FY 2025-26 but also lays a solid foundation for sustained growth in the upcoming financial year.

Commenting on the Strategic Updates

Sarthak Soni, Managing Director, Rajputana Biodiesel Limited said that Rajputana Biodiesel Limited, together with its Subsidiary, has successfully completed the supply under the previous biodiesel tender to IOCL, BPCL, and HPCL, achieving overall consolidated revenue of approximately ₹55 crore as of 31st August 2025. Building on this momentum, we have secured a new allocation of 5,405 KL of biodiesel, valued at around ₹43.50 crore, for supply during September-October 2025. This not only enhances our revenue visibility for FY 2025-26 but also reinforces our position as a reliable biofuel partner.

In support of our growth and compliance efforts, we have received regulatory approval to expand our production capacity to 90 KL per day at our Phulera, Rajasthan facility. We have also signed an MoU with the Government of Rajasthan to develop Compressed Biogas (CBG) projects in Rajasthan, and currently we are installing a deodorizer at our Meerut plant to broaden our raw material
